Introduction

The USB 2.0 IDE Adapter implements a bridge between a USB port and an ATA- or ATAPI- based mass storage device port. This bridge adheres to the *Mass Storage Class Bulk-Only Transport Specification*. Hardware design allows CBW command queuing, which allows data transfer rates up to the USB theoretical maximum with vendor specific drivers.

- Complies with USB-IF specifications for USB 2.0, the USB Mass Storage Class, and the USB Mass Storage Class Bulk-Only Transport Specification
- Operates at high (480-Mbit) or full (12-Mbit) speed
- Complies with ATA/ATAPI-6 Specification
- Supports 48-bit addressing for large hard drives
- Supports PIO modes 0, 3, 4, and UDMA modes 2, 4
- ATA interface IRQ signal support
- Support for a single ATA/ATAPI device configured either at master or slave mode

Driver Installation


Windows® 98SE

Please insert the *USB 2.0 IDE adapter* to your system and the system will find a driver for the new device. Follow the instructions until the installation is completed.

1. When the system displays "This wizard searches for new drivers for: USB 2.0 Device", please click "Next".



2. Select "Search for the best driver for your device. [Recommended]", and click "Next".



3. Select "Specify a location" and "D:\Win98", and click "Next".



4. When the system displays "Windows driver file search for the device: USB Storage Adapter AT 2(CY)", make sure the location of driver is in "D:\Win98\CY FX-AT.INF". Click "Next" to continue.



5. Once the system has finished installing the software for the new driver, click "Finish" to complete the installation.




Installation Verification

Window ME/2000/XP


After the driver has been installed, you can check if the driver has been installed in the proper location of Operating System.
